# Welcome to Beverage Solutions Group (BSG)!

We are excited that you chose our money saving condiment dispenser, lemonade/tea dispenser and/or liquid cream dispenser. In connection with your agreement to this program and product purchases required for continuation of a service agreement, BSG agrees to loan a dispenser (The "Loaned Equipment"), in exchange you adhere to the terms and the conditions below.

## Loaned Equipment

All Loaned Equipment remains the sole and exclusive property of BSG. The Loaned Equipment shall be used exclusively for BSG products which have been selected for Customer by BSG. Customer will not tamper with or alter the appearance of the Loaned Equipment and Customer shall keep the Loaned Equipment free of any liens, claims or encumbrances. BSG will repair and maintain the Loaned Equipment at no cost to Customer as long as customer meets the requirements set forth under this agreement. Customer will reimburse BSG for lost, stolen or damaged Loaned Equipment for the cost for BSG to replace the same. BSG shall not be liable to Customer for any loss, damage or expense of any kind or nature caused, directly, indirectly or consequentially, by any Loaned Equipment or the use, maintenance, operation or handling hereof, or the repairs, servicing or adjustment thereto, or any interruption of service or loss of use thereof for any loss of business or damage whatsoever or howsoever caused. BSG will ship and/or replace the Loaned Equipment at Customer's selected location(s). Customer shall not remove or permit the removal of the Loaned Equipment from such location(s) without BSG's approval. The Loaned Equipment shall at all times remain the property of BSG and Customer shall not allow any Loaned Equipment to become attached to, or a fixture of, any of Customer's premises. Customer acknowledges that the Loaned Equipment may bear one or more of BSG's trademarks, trade names, service marks or logos and shall not use the Loaned Equipment in any way that infringes or impairs any of BSG's trademarks, trade names, service marks or logos.

## Purchases

Customer shall not be required to pay any rental monies for the Loaned Equipment as long as Customer purchases products (i.e. BSG Bulk designated products including bulk Sugars, Sugar Substitutes, Creamers, or BIB Lemonade or Tea) from BSG at an average of 2 cases per dispenser per month. If customer falls below the 2 cases per month minimum customer risks losing warranty privileges and or customer may be forced out product from distributor. After determination by BSG that customer cannot meet the required minimums, BSG or BSG's distributor will remove the Loaned Equipment either via distributor pick up or arrangements made directly with BSG. BSG reserves the right to charge a prorated charge for the Loaned Equipment for period of placement.

## Taxes

Customer shall pay all sales, use, gross receipts and other taxes in the nature of sales, use or gross receipt taxes, now or hereafter imposed by any state, federal or local agency or government upon any Loaned Equipment. Customer shall pay and shall prepare and file all returns and reports for, all property taxes, ad valorem taxes and other similar taxes with respect to the Loaned Equipment, shall remit the amount of such taxes to the appropriate taxing jurisdiction on a timely basis and, upon BSG's request, provide BSG with receipts or other evidence of payment satisfactory to BSG.

## Termination

Either party may terminate this Agreement at any time by giving written notice to the other party at the address below. Upon notice of termination, Customer will cease use of Loaned Equipment and will surrender the same to BSG. BSG will not take returns of products. Customer gives BSG consent to enter its location(s) and remove Loaned Equipment at any time.

## Miscellaneous

This Agreement may only be modified in writing and signed by both parties. Both parties have full authority to enter into and perform their obligations under this Agreement and the individual(s) executing this Agreement on each party's behalf has authority to bind the party. This Agreement shall be construed in accordance with and governed by the laws of the State of Tennessee. This Agreement is binding upon the parties, their successors, permitted assigns, heirs and legal representatives.
